MINUTES OF CEMETERY COMMITTEE MEETING  
August 24, 2010**

A regular meeting of the Township of Seguin Cemetery Committee was held on August 24, 2010 at the Township of Seguin Municipal Office. After the meeting was called to order the Chair requested approval of the Agenda and the Addendum - Item #9, a request to place an oversized flat marker at Foley Memorial Cemetery was added to the Agenda.

The Committee reviewed a request from Mr. Brian McConnell (a Non-Ratepayer), requesting that he be permitted to purchase a regular sized lot at Foley Memorial Cemetery on terms. The Committee recommends that due to the very small number of lots left at this cemetery, the Committee does not wish to approve the sale of a lot on a payment plan.
