THE PURPOSE and EFFECT of the proposed Consent is to provide a right-of-way over Part 7 on Plan 42R-8518 to provide access to the Benefitting Lands (6 Shallow Way) over the Granting Lands. The property location at 6 Shallow Way currently has a right-of-way over Part 1 of the subject property, however, the actual used road is over Part 7. The application has been amended and now included Part 8 (see sketch) as part of the proposed right-of-way.

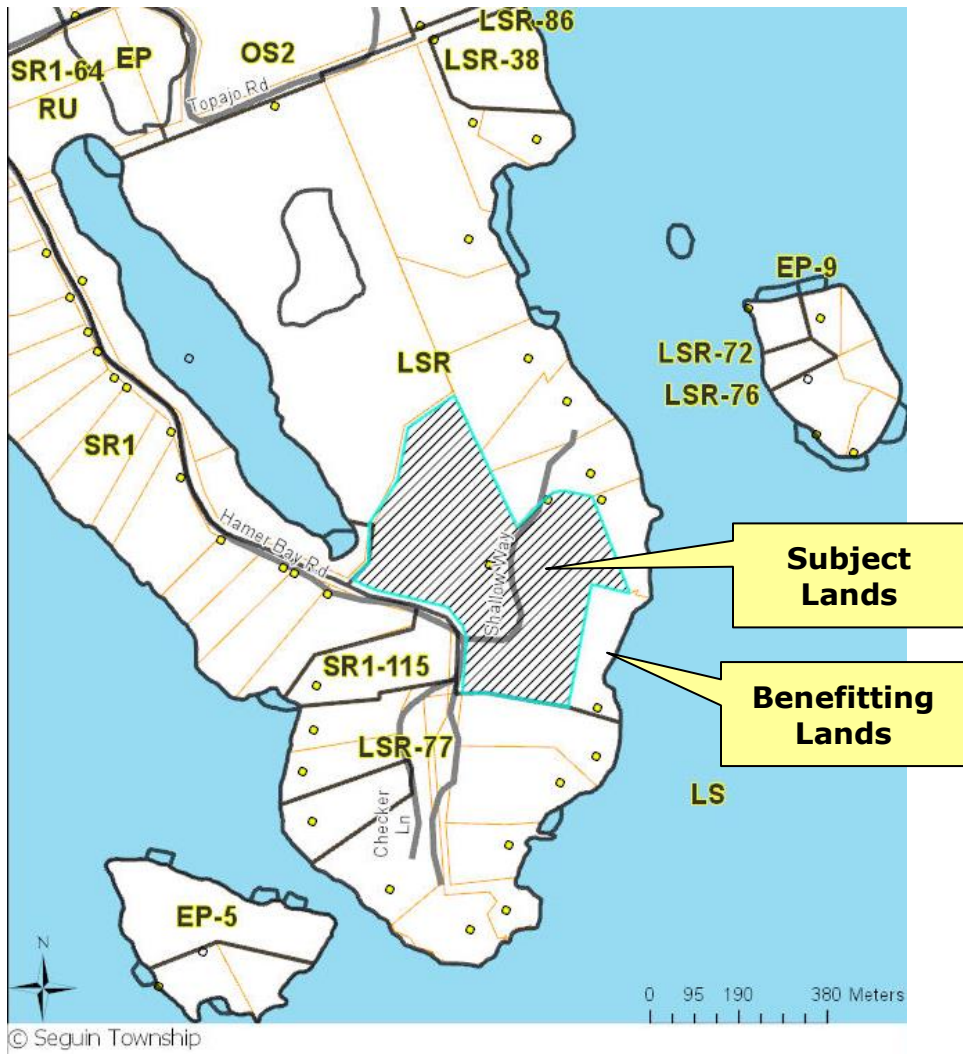
