If you wish to be notified of the decision of Council in respect of the proposed consent, you must make a written request to Council at The

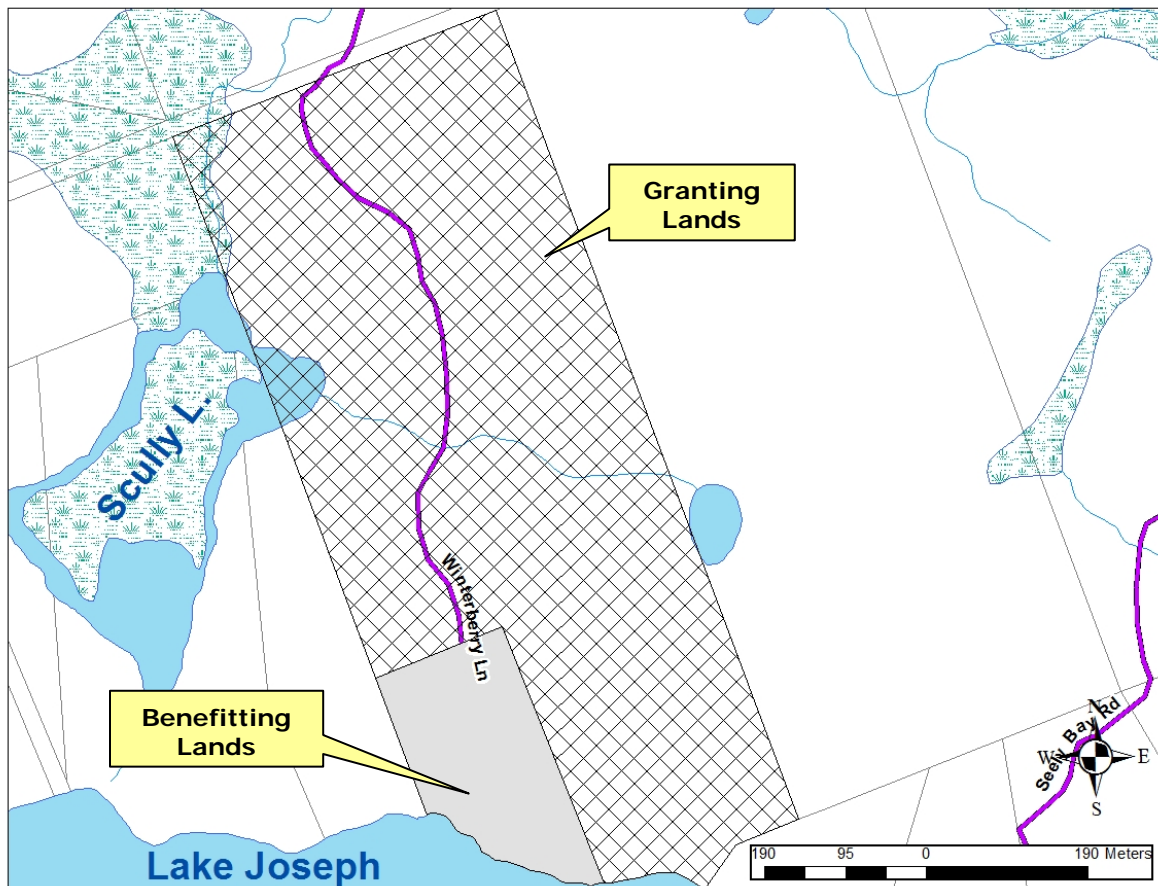

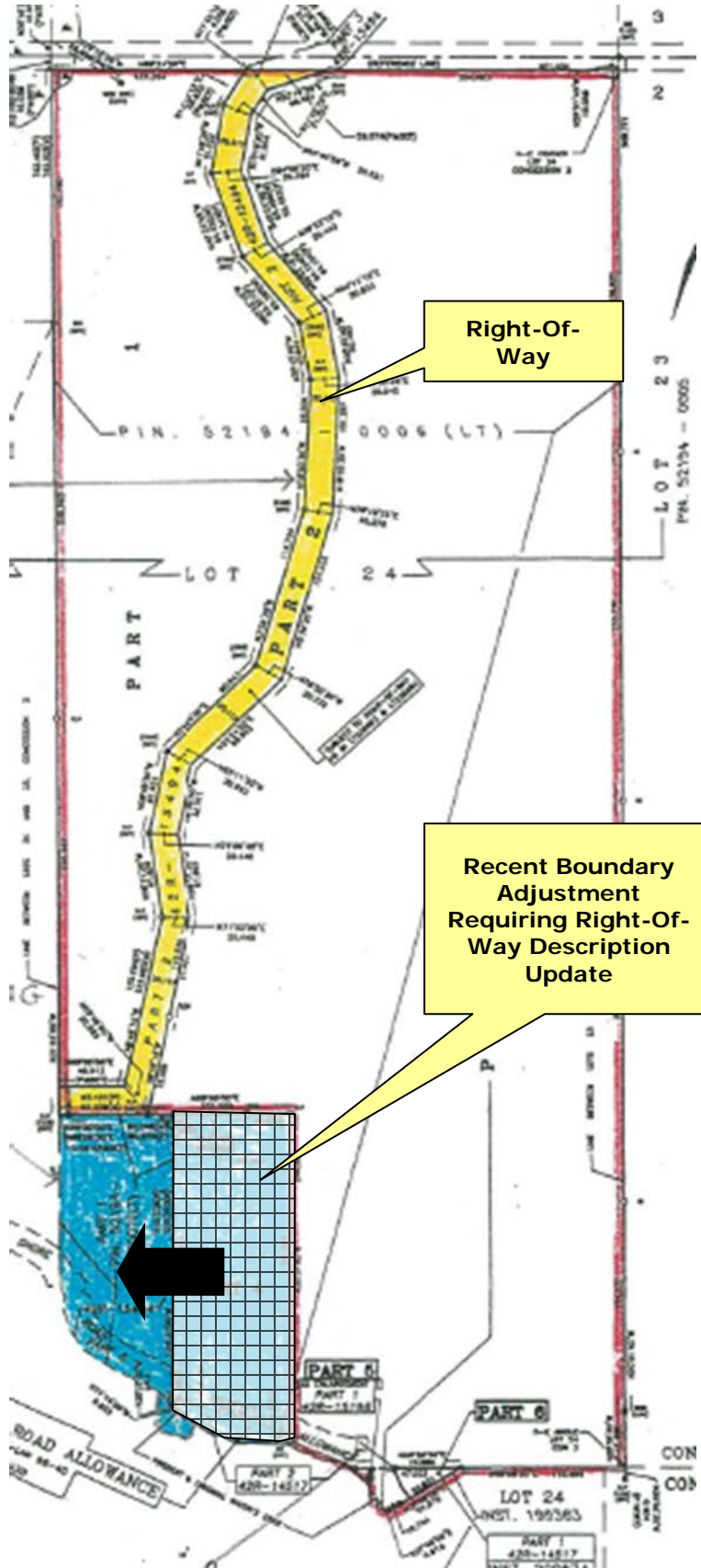
