

THE CORPORATION OF THE TOWNSHIP OF SEGUIN

BY-LAW NO. 2023-119

Being a By-law to establish a Tariff of Rates for various services related to the operation and maintenance of cemeteries under the control of The Corporation of the Township of Seguin and to repeal By-law No. 2021-090 and all other By-laws and Resolutions, or parts thereof, contrary hereto or inconsistent herewith.

WHEREAS, Ontario Regulation 30/11, Section 150 and the Funeral Burial and Cremation Services Act, 2002 provides for any cemetery operator to make By-laws governing the operation of the cemetery;

AND WHEREAS, the Council of The Corporation of the Township of Seguin is responsible for the control and maintenance of Christie Memorial Cemetery, Foley Memorial Cemetery, Humphrey-Conger Union Cemetery, Humphrey-Rosseau Union Cemetery and Seguin Falls Cemetery;

AND WHEREAS, Section 5 of the Municipal Act, R.S.O. 2001, as amended, states the powers of the Municipal Corporation are to be exercised by By-law;

AND WHEREAS, the Council of The Corporation of the Township of Seguin deems it expedient to establish fees related to cemetery services for the aforementioned cemeteries.

NOW THEREFORE the Council of The Corporation of the Township of Seguin hereby enacts as follows:

1. **THAT** this By-law shall come into force and effect on January 1st, 2024.
2. **THAT** the Tariff of Rates (Fees) for various services related to the operation and maintenance of cemeteries under the control of The Corporation of the Township of Seguin shall be as set out in Schedule "A" attached to and forming part of this By-law.


