

THE CORPORATION OF THE TOWNSHIP OF SEGUIN

By-law No. 2018-023

Being a By-law to adopt the estimates of all sums required during the year and to strike the tax rates for the year 2018

WHEREAS the Municipal Council of the Corporation of the Township of Seguin has, in accordance with Section 312 of the Municipal Act, 2001, as amended, considered the estimates of the municipality and it is necessary that \$15,252,564 for operating expenditures, \$2,861,951 for capital expenditures and \$6,001,773 for the School Boards are required. Of this, \$17,718,018 will be raised by taxation from the ratepayers of the Township of Seguin as follows:

General Purposes	\$ 11,716,245
Education Purposes	\$ 6,001,773
Total Levy	<u>\$ 17,718,018</u>

AND WHEREAS Section 312 of The Municipal Act, 2001, as amended, provides that the Council of a local municipality shall, after the adoption of estimates for the year, pass a by-law to levy a separate tax rate on the assessment in each property class;

AND WHEREAS all property assessment rolls on which the 2018 taxes are to be levied have been returned and revised pursuant to the provisions of the Assessment Act subject to appeals at present before the District Court and the Ontario Municipal Board;

AND WHEREAS "Residential Assessment", "Multi-Residential Assessment", "Commercial Assessment", "New Construction Commercial Assessment", "Industrial Assessment", "New Construction Industrial Assessment", "Landfill Assessment", "Farm Assessment", "Managed Forest Assessment" and "Pipeline Assessment" as defined in the Assessment Act, as amended by the Fair Municipal Finance Act, 1997 and further amended by Regulations thereto have been determined on the basis of the aforementioned property assessment rolls;

AND WHEREAS the tax ratios on the aforementioned property for the 2018 taxation year have been set out in By-law 2018-022 of the Township of Seguin;

AND WHEREAS Section 312 of the said Act require tax rates to be established in the same proportion to tax ratios;


NOW THEREFORE the Council of the Corporation of the Township of Seguin hereby **ENACTS AS FOLLOWS:**

1. **THAT** the estimates of the Corporation of the Township of Seguin be adopted for the year 2018 as shown on Schedule "A" attached to and forming part of this By-law; and


2. **THAT** there shall be levied and collected upon the assessable lands, buildings and businesses within the Corporation of the Township of Seguin the following municipal tax rates for the year 2018 as shown on Schedule "B" attached to and forming part of this By-law; and
3. **THAT** there shall be levied and collected upon the assessable lands, buildings and businesses within the Corporation of the Township of Seguin the following education tax rates for the year 2018 as shown on Schedule "C" attached to and forming part of this By-law; and
4. **THAT** every owner of land shall be taxed according to the tax rates in this by-law and such tax shall become due and payable on the 26th day of July, 2018, but may be paid in two installments on the 26th day of July, 2018 and the 26th day of September, 2018; and
5. **THAT** a penalty of one and one quarter percent (1 1/4%) of the amount of taxes due and unpaid may be imposed for the non-payment of taxes on the first day of default. Interest charges of one and one quarter percent (1 1/4%) of the amount of taxes due and unpaid will be imposed for the non-payment of taxes on the first day of each calendar month thereafter in which the default continues, under the provisions of Section 345 (3) of the Municipal Act, 2001, as amended; and
6. **THAT** penalties and interest added in default shall become due and payable and shall be collected as if the same had originally been imposed and formed part of such unpaid tax levy; and
7. **THAT** the Treasurer is hereby authorized to mail or cause to be mailed to the residence or place of business of such person indicated on the last revised assessment roll, a written or printed notice specifying the amount of taxes payable; and
8. **THAT** the Treasurer is hereby empowered to accept part payment from time to time on account of any taxes due; and
9. **THAT** taxes are payable at the Township of Seguin Municipal Office, 5 Humphrey Drive, Seguin, Ontario, P2A 2W8, by Pre-authorized Payment Plan, or through telephone or internet banking at the following chartered banks:

Canadian Imperial Bank of Canada; TD-Canada Trust; Royal Bank of Canada; Bank of Montreal; Bank of Nova Scotia, National Bank, and Credit Union Central.

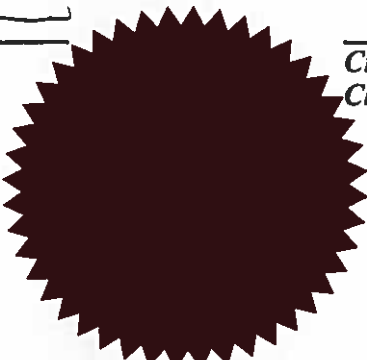
